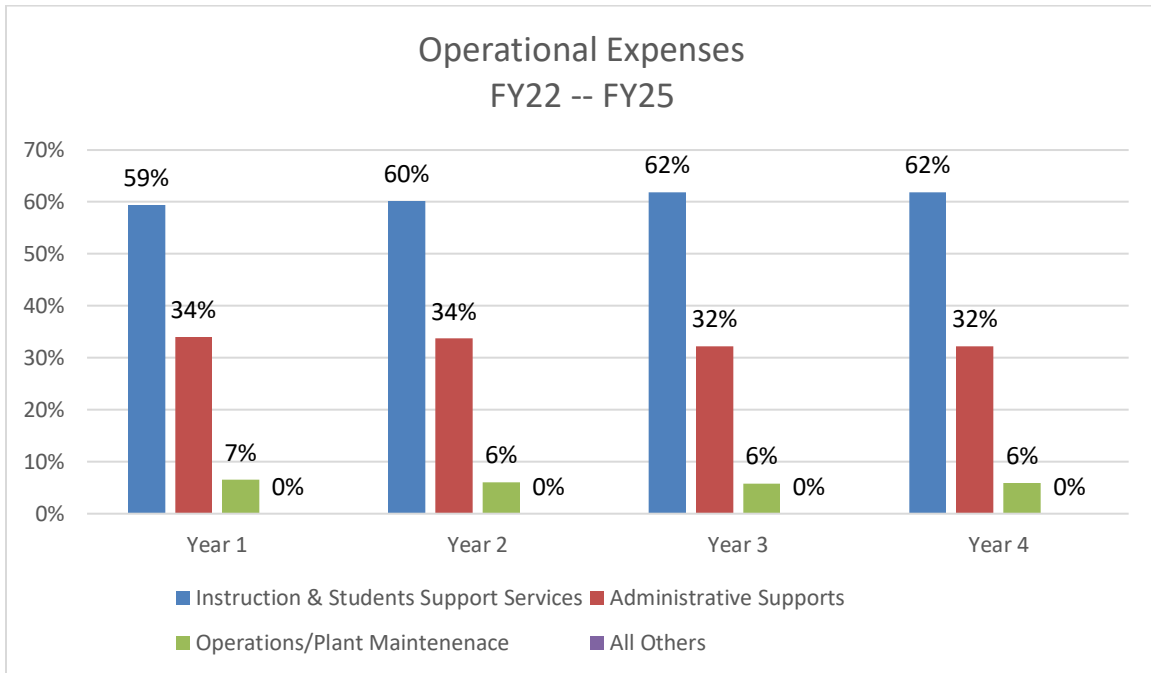

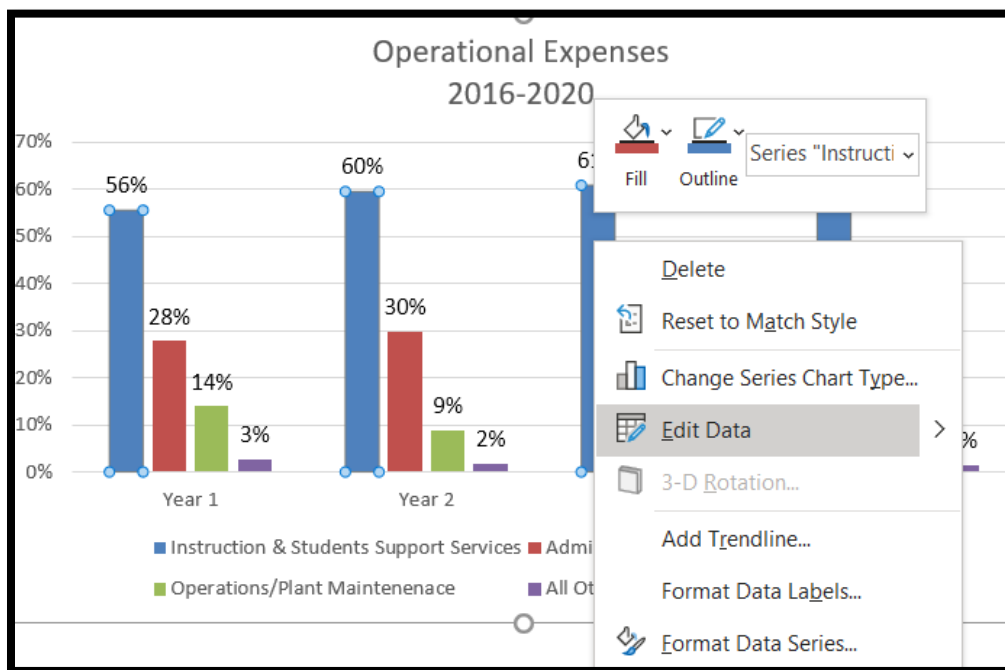
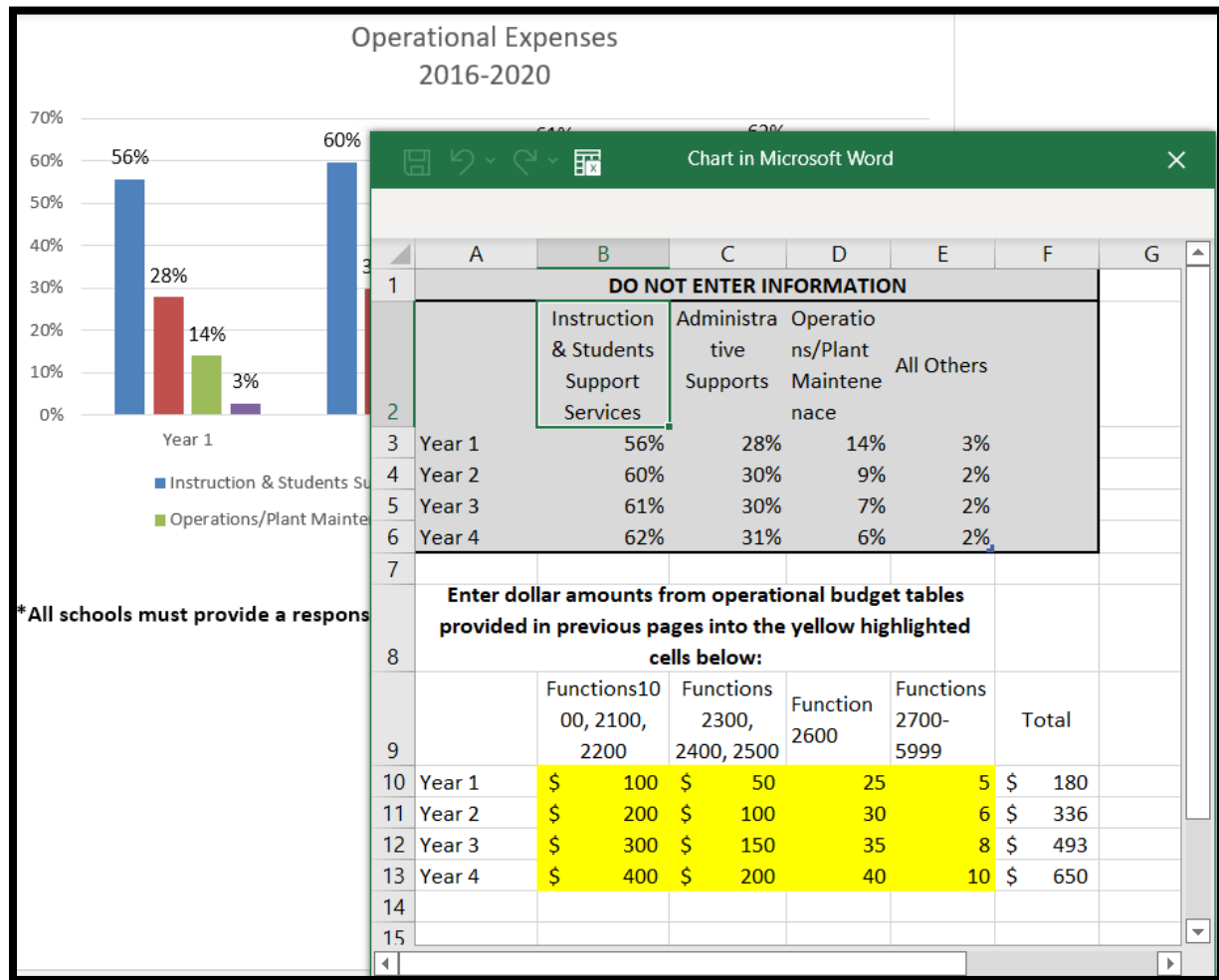


Table that appears when “Edit Data” is selected:
